The Government of Tanzania has set aside fund as a financial assistance from Development Partners and Government towards the costs of Water Sector Development Programme (WSDP II) for the financial year 2018/2019 and it intends to apply part of funds to cover eligible payments under the contract for implementation of water supply schemes in Ikungi District Council.

The **Ikungi District Council** now invites sealed Tenders from eligible and qualified Civil and Building Contractors registered with the Contractors Registration Board (CRB) in **Class V and above** for carrying out the "**Construction of One Piped Pumping Water Supply Scheme for Mtunduru Village in Ikungi District Council**" for the Financial Year 2018/2019
